# Impact to Connecticut of Trump Administration's Withholding of Federal Education Funding

Policy Briefing - July 2, 2025

#### July 28, 2025 Update

On July 25, 2025, the Trump administration directed the U.S. Department of Education to release all remaining federal education grants that had previously been impounded, following the completion of its internal review. This decision comes amid bipartisan pressure from lawmakers and ongoing lawsuits filed by several states seeking the release of the withheld funds. The funds are set to be released beginning the week of July 28, 2025.

This announcement follows the release of previously withheld Title IV-B funds on July 21, 2025.<sup>3</sup> The Trump administration stated the reinstatement of those grants would come with new requirements for states to certify compliance with certain federal civil rights laws.<sup>4</sup>

On June 30, 2025, the U.S. Department of Education informed state education agencies that over \$6.8 billion in federal K-12 education funding for the 2025-26 school year would be withheld by President Donald Trump's administration. The administration is withholding the federal funds, which were approved by Congress in March and are required by law to be distributed to state education agencies on July 1st, through a mechanism known as "impoundment." Impoundment is the delay or withholding of enacted funding through action or inaction by the president or an executive branch employee.

While the largest federal funding sources for K-12 education (Title 1-A grants for districts serving low-income students and IDEA grants for the education of students with disabilities) are not impacted by this withholding of funds, funding streams for migrant education, educator development, multilingual learners, academic enrichment, adult education, and wraparound services are all impacted.

This policy briefing provides an overview of the funding streams impacted by the administration's impoundment and includes estimates for how much federal funding is being withheld from Connecticut, its school districts, and various community organizations and programs.

#### **Key Takeaways**

- The funds being withheld by the Trump administration were authorized by Congress in March through a continuing resolution which, among other things, provided federal funding (based on federal FY 2024 funding levels) for such programs through the end of the 2025 federal fiscal year.<sup>7,8</sup>
- Over \$53.5 million in federal education funding for the 2025-26 school year is being withheld from Connecticut, which amounts to more than 10% of the federal funding the state receives annually for K-12 education.
- The withholding of federal dollars will significantly impact Bridgeport, Hartford, New Haven, and Waterbury four of Connecticut's least wealthy cities.
  - Hartford, New Haven, and Waterbury each stand to lose an estimated nearly \$3 million in federal funding from the impacted programs, while Bridgeport faces an even steeper loss at an estimated \$3.8 million.
- Several community organizations will experience sharp drops in funding, particularly those who receive Title IV grants for before- and after-school programs. The organizations include Boys & Girls Clubs, early learning centers, religious organizations, and workforce centers.
- The Connecticut Technical Education and Career System (CTECS) is projected to lose approximately \$900,000 in federal funding.
- Only seven Connecticut public school operators are projected to be unaffected by the impoundment of these federal funds, as they were not expected to receive funding from the affected federal programs/grants. These include Barkhamsted, Colebrook, Hartland, Norfolk, Norwich Free Academy, The Gilbert School, and The Woodstock Academy.

## **Overview of Impacted Grants**

Table 1 on the following page provides a guide to the specific funding streams impacted by the Trump administration's impoundment of federal education dollars. In addition to a description of each impacted grant, the table includes the estimated amount of funding impounded nationwide and for Connecticut specifically. Withheld funding estimates are derived from federal FY 2024 grant allocation amounts.

### Projected District Impacts of Impoundment<sup>13</sup>

The table on the following pages shows the funding Connecticut school districts and community organizations received during the previous fiscal year (FY 2025) from federal education grants now being impounded. While these are prior fiscal year grant allocations, they provide a reasonable estimate of the amount of federal funding expected to be withheld from school districts and organizations in the current fiscal year (FY 2026).

The table rows list public school districts and other organizations operating educational programs that received funding from the now impounded grants. The columns represent individual grant amounts with the final column showing total allocated funding.

Funding data was retrieved from the Connecticut State Department of Education's eGrants Management System with all subgrants summed by category to produce the figures shown. Title I-C is excluded from the table as no Connecticut funds are being withheld under that grant.
